ADDITIONAL REBATE INFORMATION

CLOTHES WASHER:

- ENERGY STAR appliances use about 25% less energy and 33% less water than regular washers. Visit <https://www.energystar.gov/most-efficient/me-certified-clothes-washers/> for a list of qualifying appliances.
- The City of Healdsburg only provides energy and water rebates for front loading clothes washers listed as ENERGY STAR Most Efficient.
- Top load models and model with Sliver Ion technology are not eligible for the rebate.

LOW FLOW TOILETS:

- The City of Healdsburg only provides water rebates for *Water Sense Labeled* toilets and are ≤ 1.28 gallons per flush.

GREYWATER:

- Currently, only laundry-to-landscape systems are eligible for rebates through the City's program.

IRRIGATION & SMART METERING DEVICES SYSTEMS:

- Program requires itemized receipt identifying the cost of materials.
- Customers can receive \$100 per eligible irrigation system upgrade or smart metering device (**i.e., Flume**)
- Up to \$400 rebate per meter.
- Eligible upgrades: pressure regulating equipment, conversion to drip system, check valves, rain/flow sensors, irrigation sub-meter and weather-based and moisture sensing controllers (must be *Water Sense Labeled*)
