## Proposal – Bike Healdsburg, Inc.

- 15 Person Pedicab
- 3 Daily Tours, 7 Days a Week
- No Alcoholic Beverages
- No Amplified Sound





# City Council Direction From March 5, 2018

- Return with Resolution (No Alcoholic Beverages; No Amplified Sound)
- Work with Applicant to Revise Routes
- Research Whether the Council Could Rescind Resolution Once Adopted



# Proposed Resolution

- Would authorize “Bike Healdsburg” to operate pending the adoption of a comprehensive pedicab ordinance.
  - No Alcoholic Beverages
  - No Amplified Sound
  - Routes/Schedules/Times Approved by the Police Department
  - Routes/Schedules/Times Can be Changed by the Police Department
  - Resolution Valid Until a Pedicab Ordinance is Adopted and Takes Effect

- Three Routes Have been Reviewed and Tentatively Approved
  - Police Department Review
  - City Traffic Engineer Review

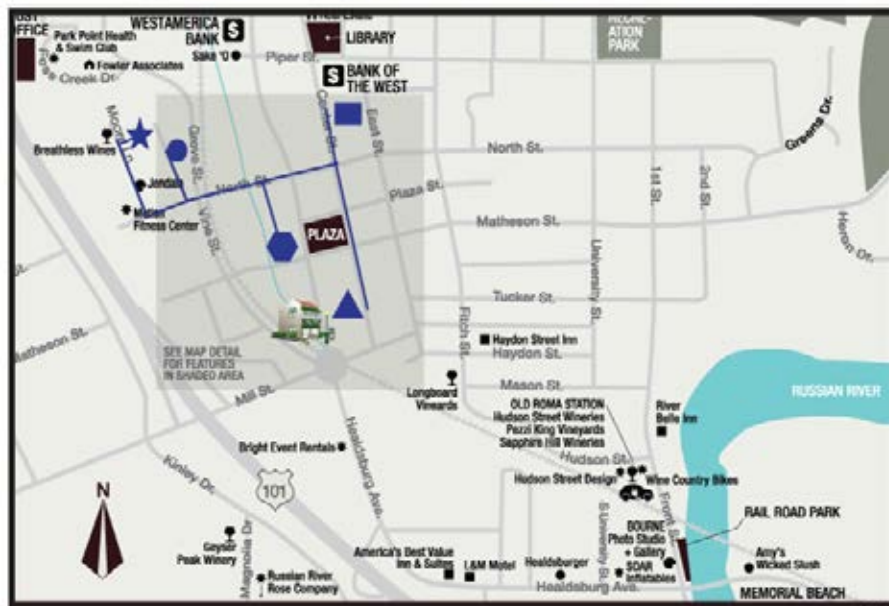

# Legal Issues

- San Diego Cases – Allow City to Revoke/Not Renew Pedicab Permits
- However, Cases are Not Published – Not Yet Citable Law
- Other Cities with pedicab ordinances include a license issuance and revocation procedure.
- Cautious Approach would allow for some due process in revocation/denial/suspension of a pedicab permit in the comprehensive ordinance



## Recommendation/Alternatives

- Staff Recommendation: (1) Direct staff to return with a comprehensive ordinance authorizing and regulating the operation of pedicab businesses within the City of Healdsburg, and (2) Adopt a resolution authorizing Bike Healdsburg, Inc. to operate a pedicab business within the City of Healdsburg pending the adoption of a comprehensive pedicab ordinance.
- City Council Alternatives:
  - Direct staff to return with a resolution authorizing Bike Healdsburg, Inc. to operate a pedicab business in the City of Healdsburg that is different than the attached resolution; and/or
  - 
  - Do not adopt the attached resolution, and direct staff to return with a comprehensive pedicab ordinance (which would govern Bike Healdsburg Inc.'s application);
  - 
  - Receive the staff report and provide no further direction to staff. Since State law requires a jurisdiction adopt a resolution or enact an ordinance before pedicabs can operate, this option would maintain the status quo, which prohibits the operation of pedicabs in the City.
